## Information and Resources

An important part of the process of planning with our relatives who have a disability is access to relevant and accurate information at the time it is needed. Pave the Way aims to assist families in this way by providing information relevant to planning, including housing and funding options amongst others.

A range of information sheets is being designed to help people make sense of the often complex and changing information that is provided by government departments and agencies. This written information, along with phone, email and personal contact, aims to assist families as they explore the many overlapping issues that are part of planning for a good life now and in the future. The first area investigated looks at the range of housing options that may be available for people who wish to move out of home, or when it is no longer possible for them live with their family. This will be available from February next year.

## Regional Responses by Pave the Way

Pave the Way has a commitment to support the efforts of families throughout Queensland to safeguard the future of their family member with a disability. Prior to our recent funding increase, our responses to requests by families and organisations representing families in the regions were supported and funded by local groups and regional coalitions supported mainly by the Disability Sector Training Fund.

Pave the Way's statewide support has largely been in the provision of workshops and small group meetings or one on one discussions with family members. Jeremy Ward and Sharon Bourke have presented workshops on Planning for Today, Tomorrow and The Future and Building Lifelong Support Strategies: Networks & Support Circles in most regions across Queensland.

With the receipt of funding earlier this year, Pave the Way now has more capacity to work developmentally in regions to assist families to strengthen their efforts and build on their capacity within local communities to safeguard the future of their family member with a disability. Currently, Cairns & Goondiwindi are two regions of focus for Pave the Way. These regions were chosen following interest expressed by families at workshops held in those areas and also in response to requests from individual families for assistance to begin or develop support circles.

Recruitment and support of local facilitators, to work with families in the ongoing development of support circles and networks, is now a priority in both regions.

Our work is based on strong beliefs, including:

- Work of families, and Pave the Way, must be driven by families at their pace;
- Families have capacity, energy, commitment and imagination;
- Families' efforts to secure a decent life and a great future for their family member are highly significant;
- Relationships are one of the important keys to safeguarding people and those relationships reside in families and in local communities;
- Families know their own communities best and are best placed to advise on what will assist them to build capacity and strengthen their efforts locally;
- Pave the Way aims to work with humility alongside families when invited.

## Commonwealth Government Succession Planning Initiative

Pave the Way continues to monitor the development of the Commonwealth Government Succession Planning initiative, which includes Special Disability Trusts and a booklet on future planning.

### Special Disability Trusts

Special Disability Trusts (SDTs) took effect on 20 September 2006. Where the trust satisfies specific requirements Centrelink concessions apply. Trust funds up to \$500,000 will not be included when assessing eligibility for Centrelink pensions. If a trust does not comply, Centrelink asset and income tests apply. *This includes trusts under a will.* The current Centrelink asset test limit is \$278,000 for a single pensioner who doesn't own their home and \$161,000 (plus home) for a single homeowner. Trust funds can be used only for "care and accommodation" and cannot be used for other expenses, such as holidays or household items that are not disability related.

### Discussion Paper on the Needs of Families Planning for the Future

The Commonwealth Government has also called for submissions on the needs of families when planning for the future. A very limited round of consultations is being carried out, with only one meeting in each State - Queensland's was in Brisbane in November. FaCSIA has issued a discussion paper "Succession Planning for Carers" and called for **submissions by 15 December 2006**.
