In 2012 we will be developing new workshops and information documents, especially in the area of support circles. We will also work on the re-design of our website and current information documents which will incorporate the use of Pave the Way's own logo. If you have any comments or suggestions about any of these we would be happy to hear from you, especially ways in which we can be more effective in making contact with people in regional areas when we have events planned for a particular town or district.

## Planning ahead for 2012 – Workshops and other events

We look forward to offering a range of workshops in different regions of Queensland in 2012. Dates for some of these are already on the workshop calendar and are listed on the back of this newsletter.

To help with your planning we have listed the dates for our live-in weekends in 2012. The brochure for the first of these, in Toowoomba, is included with this newsletter. If you are interested in attending please contact the office for the expression of interest form. This form can also be downloaded from the website.

- 2 Day Workshop. 23 – 25 March. Toowoomba.
- 6 Day Workshop. 15 – 17 June and 24 – 26 August. Coolumb.
- 2 Day Workshop. October. Date and Location to be advised.



The design of these live-in workshops requires two people to attend together. Two parents usually attend but sometimes one parent attends with another family member or friend.

Another pre-requisite is to have attended the one day workshop, "Planning for Now, Tomorrow and the Future", so that all participants have a clear understanding of the ideas that form the basis of the longer workshop. If you are interested in coming to a live-in workshop at any time it is a good idea to attend *Planning for Now, Tomorrow and the Future* whenever you see it offered in your area. This workshop is a good introduction to the ideas of vision and planning as well as to important legal issues. It is also one pre-requisite for some of the shorter workshops we will offer in 2012.

Dates for *Planning for Now, Tomorrow and the Future* so far are:

- 22 February – Warwick area
- 7 March - North Brisbane
- March – Maryborough (date to be confirmed)
- 21 April – Sunshine Coast
- 5 May – Brisbane Southside.

Other one day and shorter workshops will be planned as the year progresses, especially for regional areas. Dates for these will be announced in future newsletters and will be added to the calendar on the website. Flyers for all workshops will be posted or emailed to the relevant areas of our mailing list as they become available. All our short workshops or one day events are free for families but it is important to book so that we can make arrangements for resources and catering as well as accommodation and travel in regional areas.

## 2012 Road trip

### North West Queensland Road Trip – 21 – 30 May 2012

Following the successful South West Queensland Road Trip in March/April 2011, *Pave the Way* consultant Jeremy Ward is planning another Road Trip in May 2012, this time to North West Queensland. Jeremy will again travel to meet with families in their homes, offering one-on-one consultations about planning, safeguarding the future, building networks of support, and relevant legal issues.

The Road Trip will take ten days, from 21 to 30 May 2012 and will include the Atherton Tableland, Georgetown, Normanton, Mt Isa, Cloncurry, Richmond, Charters Towers, Ingham and back to Cairns. This trip will focus on making contact with families away from the larger coastal centres so Jeremy will not be meeting with people in the Cairns or Townsville districts.

### Special Disability Trusts – *Pave the Way* Information Sheet

Since the Commonwealth Government introduced Special Disability Trusts in 2006, there have been a number of changes to the original eligibility criteria and rules associated with these particular trusts. *Pave the Way* has followed these changes with a number of articles in our newsletters.

So that all these changes are included in the one document, *Pave the Way* has developed an information sheet based on an extract from a revised version of our booklet "*Planning for Now, Tomorrow and the Future*". This information sheet sets out the purpose for which Special Disability Trusts were established, the definition of "severe disability" required to determine whether an individual can be an eligible beneficiary of a Special Disability Trust, the uses to which Special Disability Trust funds can be put, including the recently introduced "discretionary" expenditure, the Centrelink and public housing concessions which Special Disability Trusts attract, and other related issues.
